Frequently Asked Questions

Do I need to use Oaksrest Vineyards caterers?

Yes, we do not allow outside caterers. Together we can work out the perfect menu for your special day that will suit your requirements and budget.

Can I bring in my own wedding cake?

You are more than welcome to bring in your own wedding cake.

I would like to get dressed for my wedding on the premises. Do you have a room or cottage available?

Yes, we do at an additional cost. For all accommodation-related questions, please contact Louisa at phillipenlouisa@gmail.com

I do not like the chairs/tables/linen included in the venue fee. Can I please get other ones?

You are more than welcome to source different furniture or linen for your own account. Please note that cost cannot be subtracted from the venue fee and the fee must be paid in full regardless of using the venue's furniture and linen or not.

What is your policy on children attending?

We love children and we have the most beautiful gardens and open spaces for them to play around, but we also have a lot of water streams and dams close to the venue, therefore it is the parents' own responsibility to look after their children.

Oaksrest Vineyards cannot be held liable if anything happens to a child.

In terms of catering children under the age of 4 is free of charge, and children 4 to 12 years old will be charged 50% of the cost. Children of 12 years and up will be viewed as an adult.

How does the bar service work?

You can have a total cash bar where guests pay for their own drinks, or you can run a tab for an open bar for your guests.

Our prices for liquor are very reasonable and market-related. If you would like to bring in your own drinks for pre-drinks a corkage of R70 per person will be charged.

You are allowed to bring two bottles of champagne/sparkling wine as well as two bottles of wine per table. Extra bottles of wine will be charged R70 per bottle for corkage.

How do the menu selection and catering work?

You will be able to compile your own menu from a list of dishes and our experienced catering staff will be more than willing to assist you with any custom choices. We can do canapés, spitbraais, warm and cold buffets and plated dishes

How will the payments work?

*A 50% non-refundable deposit as part of the **venue hire** will be required to secure booking.*

1 months before the wedding you must pay your venue hire in full.

15 days before the wedding, the total bill must be settled (food, décor, etc.)

When can we collect our decor and personal items after the wedding?

If décor cannot be collected on the Monday (or following workday) after your wedding, it can be done on the Sunday or the day after the wedding between 9:00 and 12:00 only.

Oaksrest Vineyards takes no responsibility for injuries, damage to personal belongings or items hired by you, or damage caused by rain or fire.

WEATHER

Oaksrest Vineyards takes no responsibility for outdoor events and the client remains responsible for any extra costs involved should a radical shift in the weather affect the arrangements of the function.

REMOVAL OF DÉCOR

All décor must be removed from the premises on the Monday after the wedding before 10:00 am, or on the **Sunday between 9:00 and 12:00 am**. Oaksrest Vineyards takes no responsibility for loss or damage to any décor.

CONFETTI

Only biodegradable confetti is permitted. Popcorn, feathers, spray string, and streamers are not allowed.

SMOKING

Smoking is only permitted outside.

PAYMENTS

To secure your booking, 50% (non-refundable) of the venue hire must be paid. 2 months prior to the wedding, 50% of the total outstanding balance (venue hire) must be paid.

10 days before the wedding the account must be settled in full.

CANCELLATIONS

If you cancel your wedding less than 6 months prior to the wedding date, you will be liable for the full venue hire.

No accommodation will be reserved for you and your guests on the weekend of your wedding without prior arrangement and accommodation deposit payments. We work strictly on a first come first serve basis.

SET-UP & DISMANTLING

The venue is available for set-up the day prior to the event from 08:00 to 19:00. Dismantling must please take place the day after the function between 9:00 and 12:00, or the following working day (usually the Monday).

To Be completed and signed before payment of deposit.

1. RESERVATIONS WILL ONLY BE CONFIRMED UPON RECEIPT OF A DEPOSIT OF **R10 000-00** WHICH IS REQUIRED WITHIN ONE (1) WEEK OF MAKING THE PROVISIONAL BOOKING. ONCE A CONFIRMATION DATE EXPIRES, THE PROVISIONAL BOOKING WILL AUTOMATICALLY BE RELEASED.

2. CANCELLATION / POSTPONEMENT POLICY

- 2.1 100% OF THE DEPOSIT WILL BE REFUNDED IF YOU CANCEL/POSTPONE 12 MONTHS OR LONGER BEFORE THE BOOKED DATE
- 2.2 80% OF THE DEPOSIT WILL BE REFUNDED IF YOU CANCEL/POSTPONE 10 TO 12 MONTHS BEFORE THE BOOKED DATE
- 2.3 60% OF THE DEPOSIT WILL BE REFUNDED IF YOU CANCEL/POSTPONE 8 TO 10 MONTHS BEFORE THE BOOKED DATE
- 2.4 40% OF THE DEPOSIT WILL BE REFUNDED IF YOU CANCEL/POSTPONE 6 TO 8 MONTHS BEFORE THE BOOKED DATE
- 2.5 20% OF THE DEPOSIT WILL BE REFUNDED IF YOU CANCEL/POSTPONE 4 TO 6 MONTHS BEFORE THE BOOKED DATE

3. DEPOSITS ARE TO SECURE A SPECIFIC DATE. IF THE WEDDING DATE IS CHANGED OR POSPONED WITHIN THE SIX (6) MONTHS AS IN POINT 2 ABOVE, ANOTHER DEPOSIT WILL BE REQUIRED TO SECURE THE NEW DATE.

4. ALL ACCOUNTS INCLUDING YOUR BAR LIMIT AND ANY OTHER PRE-ARRANGED EXPENSES ARE TO BE SETTLED IN FULL FOURTEEN (14) DAYS PRIOR TO THE FUNCTION.

5. WE RESERVE THE RIGHT TO CHARGE A BREAKAGE DEPOSIT, PAYABLE FOURTEEN DAYS PRIOR TO THE FUNCTION, WHICH IS REFUNDABLE SEVEN (7) DAYS AFTER THE FUNCTION, IF NO DAMAGE HAS OCCURRED. THE DEPOSIT WILL VARY DEPENDING ON THE SIZE AND POTENTIAL RISK OF THE FUNCTION. ALL ADDITIONAL COSTS MUST BE PAID IN FULL BEFORE DEPARTING FROM THE VENUE AFTER THE WEDDING.

6. ALL PRICES QUOTED ARE SUBJECT TO CHANGE, PROVIDED THAT THE CLIENT IS INFORMED OF SUCH CHANGES AT LEAST THIRTY (30) DAYS PRIOR TO A RESERVED BOOKING.

7. THE CLIENT WILL NOTIFY OAKSREST VINEYARDS GUEST FARM NOT LESS THAN FOURTEEN (14) DAYS PRIOR TO THE FUNCTION OF THE CONFIRMED NUMBER OF GUESTS THAT WILL BE ATTENDING. THIS WILL BE THE NUMBER USED TO FINALISE YOUR CATERING ARRANGEMENTS AND PAY THE BALANCE OF YOUR ACCOUNT.

8. IF MORE GUESTS THAN THE ORIGINAL AMOUNT AGREED ON AND PAID FOR ARRIVE, THE CLIENT WILL BE CHARGED THE SAME "PER HEAD RATE" AS THE REST OF THE GUESTS PER EXTRA GUEST.

9. A MAXIMUM OF 130 GUESTS WILL BE ALLOWED AT THE VENUE PER FUNCTION. MANAGEMENT RESERVES THE RIGHT TO CLOSE THE GATES AND RESTRICT FURTHER ENTRY SHOULD THIS AMOUNT BE EXCEEDED. RIGHT OF ADMISSION IS RESERVED AT ALL TIMES.

10. THE COMPANY RESERVES THE RIGHT TO CANCEL ANY BOOKING FORTHWITH AND WITHOUT LIABILITY ON ITS PART IN THE EVENT OF ANY DAMAGE OR DESTRUCTION OF THE VENUE BY FIRE OR ANY OTHER CAUSE, ANY SHORTAGE OF LABOUR OR FOOD SUPPLIES, STRIKES, LOCKOUTS OR INDUSTRIAL UNREST, OR ANY CAUSE BEYOND THE CONTROL OF THE COMPANY WHICH SHALL PREVENT IT FROM PERFORMING ITS OBLIGATIONS IN CONNECTION WITH ANY BOOKINGS IN ITS ESTABLISHMENT.
